Max Bowen was born July 30, 2007 to Josh and Keyla Bowen of New Salisbury. Within a few months of birth, Max showed many delays. Evaluations for physical, visual, and neurological concerns were conducted. Max received physical, occupational, and developmental services through Indiana First Steps. At age 3, Max received his wheelchair and attended the special needs preschool at North Harrison Elementary. Max continues to attend school and receive daily therapy from the great team at North Harrison Elementary.

Max was referred to the Cleveland Clinic for extensive neurological and genetic testing to find a diagnosis for his condition. The evaluation showed the cerebellum, the part of the brain that controls motor skills is not developing normally and Max will undergo regular MRI to monitor for cerebellar atrophy. Max has global delays that include gross and fine motor skills, balance difficulties, speech, vision, and cognitive abilities. Although Max has many physical and neurological needs, he is greatly loved by his family and friends. As Max grows, he requires specialized equipment including modification of his home and furnishings for his care and safety. As a rule, this equipment is costly and not covered by medical insurance.
